LIVINGSTON GUN CLUB RELEASE AND INDEMNIFICATION AGREEMENT

MICHIGAN SPORT SHOOTING RANGES ACT SECTION 4: ACCEPTANCE OF RISK

Each person who participates in sport shooting at a sport shooting range that conforms to generally accepted operation practices accepts the risks associated with the sport to the extent the risks are obvious and inherent. Those risks include, but are not limited to, injuries that may result from noise, discharge of a projectile or shot, malfunction of sport shooting equipment not owned by the shooting range, natural variations in terrain, surface or subsurface snow or ice conditions, bare spots, rocks, trees, and other forms of natural growth or debris.

AGREEMENT

IN CONSIDERATION of my being given permission to participate in activities at Livingston Gun Club (hereafter "LGC"), I agree to sign and enter into this release and indemnification agreement.

I am entering into this agreement freely, voluntarily, and knowingly, and specifically state that:

1. I have read and understand Section 4 of the Michigan Sport Shooting Ranges Act
2. I am not dazed, suffering from shock or under the influence of drugs or alcohol and;
3. I understand that this is a full and complete release and indemnification agreement and;
4. there has been no fraud or other conduct used in obtaining my signature and agreement to this document.

I will comply with all rules and regulations of LGC. If I have questions, or observe any unusual or unnecessary hazard during my participation, I will immediately bring such to the attention of the nearest official.

I understand that observing and/or participating in LGC activities will expose me to certain risks inherent to the use of firearms and related activities. These include, but are not limited to, personal or bodily injury, death and/or property damage. I agree to assume and accept the risks inherent in observing and/or participating in LGC activities.

I represent that I have no drug, health, or mental problem that could or will interfere with my observing and/or participating in LGC activities. I agree that I am responsible for my own safety and the safety of any guest or child that I may bring to the premises of LGC.

I agree that LGC, its members, officers, directors, employees, agents, representatives, affiliates, subsidiaries, successors or assigns and all participating groups and persons officially connected with the activities, will not be liable if I, my guest or child suffer any personal or bodily injury, death or property damage as a result of ordinary negligence.

I further agree that in the event that LGC, its members, officers, directors, employees, agents, representatives, affiliates, subsidiaries, successors or assigns and all participating groups and persons officially connected with the activities, become liable in any way of contribution, indemnification, judgment, verdict, award, or otherwise, to any party as the result of my actions, negligence or injury, I agree to indemnify and hold harmless LGC, its members, officers, directors, employees, agents, representatives, affiliates, subsidiaries, successors or assigns and all participating groups and persons officially connected with the activities, from any and all claims, demands, actual legal costs or expenses arising out of said actions, negligence, or injury, no matter who might bring said claim, if any be brought.
